Preferred Jump Height Eligibility Requirements:

1. To qualify for a preferred status in DACOF, a dog must compete only in preferred classes after **February 1, 2016**.
2. Preferred is defined in accordance with AKC jump height requirements that allow a dog to compete at 4” lower than their standard height as determined by their jump height card.

Competition Level Eligibility Requirements:

Early Bird Discount Qualification Requirements:

1. Team members must submit entry form as a team with all fees included in one mailing.

4. Team members submitting individual entry forms will not be entitled to the discount.

All Handlers acknowledge that any dog entered at a Preferred Jump Height has been jumping exclusively at a Preferred Jump Height since 2/1/2016 and is entered at the level of their highest Standard title in EITHER regular or preferred. The penalty for violating the Preferred Eligibility Rules and/or the Competition Level Eligibility Rules for DACOF 2016 will be the disqualification of the dog and the elimination of the dog's team from being considered in Team Final Standings.
